



## Statement of RoHS Compliance

21 March 2024

This document certifies that all products supplied by IQD Frequency Products Ltd., are compliant with Directive 2011/65/EU (EU RoHS 2) of the European Parliament and of the Council of the 8<sup>th</sup> of June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (RoHS directives) when the specific IQD part number has a 'LF', prefix. The products are deemed as compliant in accordance with the definitions given in the directives.

This document also acknowledges that on the 4<sup>th</sup> of June 2015, European Commission Delegated Directive 2015/863EU (EU RoHS 3) of the 31<sup>st</sup> March 2015 amending Annex II to Directive 2011/65/EU of the European Parliament and of Annex II to Directive 2011/65/EU is replaced by the text in the Annex of this directive. This amendment adds four phthalates to the list of restricted substances. The member states have be instructed to implement the new regulation into force by the 22<sup>nd</sup> June 2019.

IQD Frequency Products certifies that 'LF', products are compliant with the 2015/863 (EU RoHS 3) Directive which limits the concentrations of the following chemicals as below;
