Description

- 5 x 3.2mm crystal oscillator
Ceramic package with a seam sealed metal lid, hermetically sealed
- Model **CFPS-9**
- Model Issue number **8**
- Note: Please be aware that devices supplied against this model may show slight cosmetic differences depending upon the frequency and specification, however, all electrical details remain as per the model specification.

Frequency Parameters

- Frequency **32.0MHz**
- Frequency Stability **±50.00ppm**
- Operating Temperature Range **-40.00 to 85.00°C**
- Ageing **±3ppm max per year @25°C**

Output Details

Output Control

- Enable/Disable Operation:
Logic '1' (>70% VS) to pad 1 enables oscillator output
Logic '0' (<30% VS) to pad 1 disables oscillator output; when disabled the oscillator output goes to the high impedance state
No connection to pad 1 enables oscillator output
Standby Current: 10µA max, 0.9µA typ @25°C

Environmental Parameters

- Storage Temperature Range: **-55 to 125°C**
- Shock: MIL-STD-202F, Method 213B: 1000G, 0.5ms, 1/2 sine wave
- Vibration: MIL-STD-202F, Method 204D, Test Condition D: 20G (10Hz-2000Hz), 4hrs in 3 mutually perpendicular planes (total 12hrs)

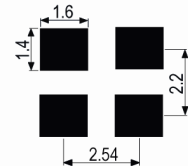
